 - We now have filed all requested docs with the state now waiting
 - BUSC wants us each to re-register for Cal North under our own entities once dissolution is completed

Facilities: Ryan Callahan

- Ryan gave a general update on seeking potential sites for new RAGE offices and facilities.
 - No new update with developer, focus needs to be on fundraising in 2025.
- BUSC Futsal Courts
 - 3 futsal courts are being installed at Alameda County Fairgrounds
 - Estimated to be up and running by April of 2025, Minimum 5 year duration
 - BUSC is looking for a \$200k commitment from RAGE, Total project cost is \$1.17 million
 - They plan to rent the courts to outside groups at \$125 an hour each
- Path Forward to negotiation with BUSC
 - Capital commitment we agreed, Number of hours we can get for \$200K
 - RAGE ask on hours/use
 - 22 weeks a year, 22 hours per week, 484 hours per year
 - 6 Weekends per year to hold playdates
